

NOTIFICATION

Whereas the draft of the Karnataka Backward Classes and Minorities Department Services (Cadre and Recruitment) Rules, 1996 was published as required by sub-section (2) of Section 3 of the Karnataka State Civil Services Act 1978 (Karnataka Act 14 of 1990) in Notification No.DPAR 46 SRD 96 dated: 6th July 1996 in Part 4 section 2-C (1) of Karnataka Gazette (Extraordinary) dated 6th July 1996 inviting objections and suggestions from all persons likely to be affected there by within 30 days from the date of its publication in the official Gazette.

And whereas the said Gazette was made available to the public on 6th July 1996.

And whereas objections and suggestions received have been examined by the Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section-3 read with section-6 of the Karnataka State Civil Services Act 1978 (Karnataka Act-14 of 1990) the Government of Karnataka hereby makes the following rules, namely:-

1. Title and commencement:-

- (1) These rules may be called the Karnataka Backward Classes and Minorities Department Services (Cadre and Recruitment) Rules, 1997.
- (2) They shall come into force from the date of their publication in the official gazettee.

2. Method of recruitment and minimum qualification:-

In respect of each Category of posts and scale of pay specified in column (2) of the Schedule below, the number of posts, method of recruitment and minimum qualifications, if any, shall be as specified in the corresponding entries in columns (3), (4), (5) and (6) there of.

3. Repeal:- The Karnataka Backward Classes and Minorities Department Services (Recruitment) Rules, 1961 are hereby repealed.

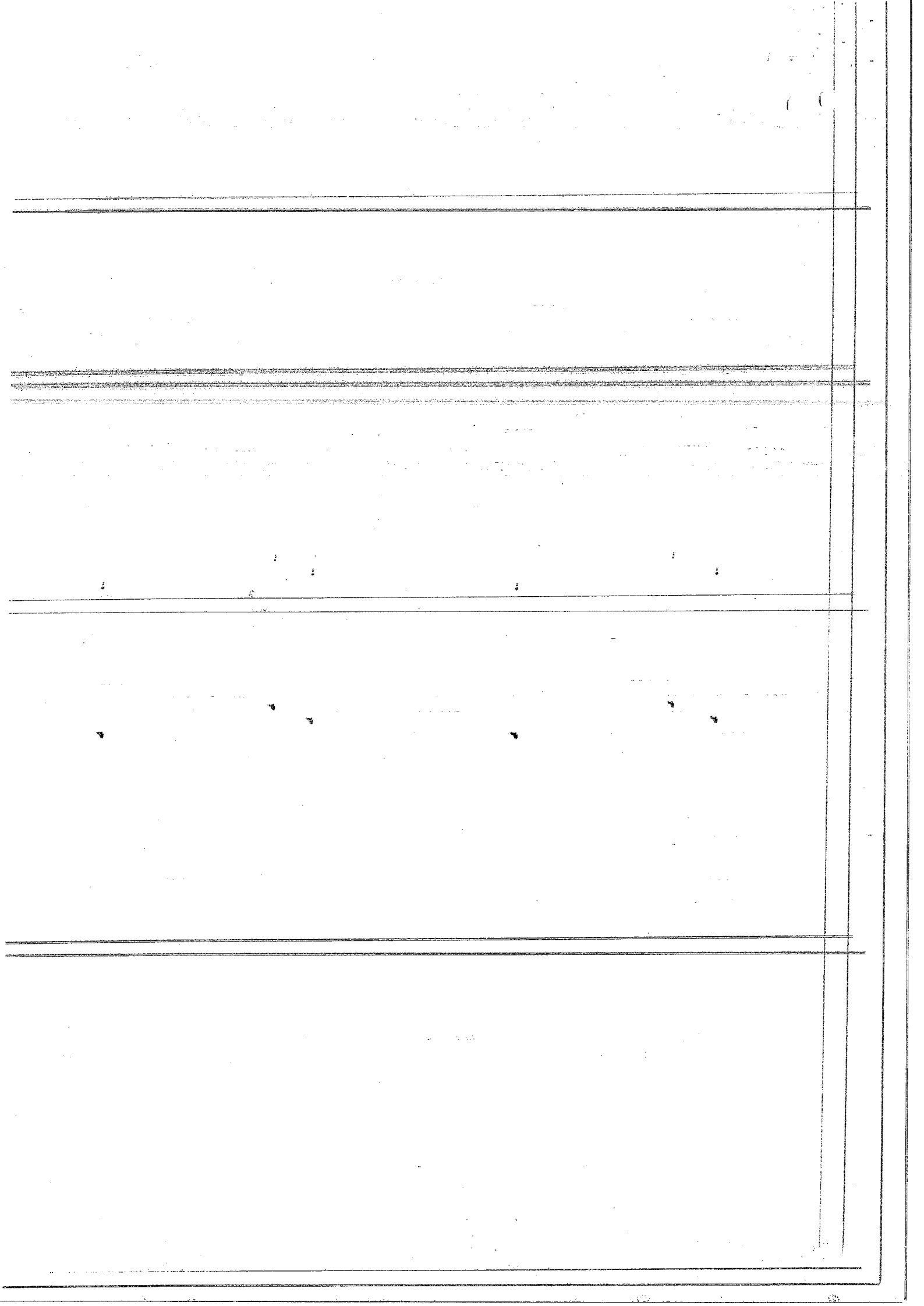

Whereas the draft of the Karnataka Backward Classes and Minorities Department Services (Cadre and Recruitment) (Amendment) Rules, 2002 was published as required by sub-section (2) of Section 3 of the Karnataka Civil Services Act, 1978 (Karnataka Act 14 of 1990) in Notification No. DPAR 17 SRD 2002 dated 21-6-2002 in Part-IV-A of the Karnataka Gazette (Extra-ordinary) dated 21-6-2002 inviting objections and suggestions from all persons likely to be affected thereby within thirty days from the date of publication in the official Gazette.

And whereas the said Gazette was made available to public on 21-6-2002.

No objections and suggestions have been received by the Government.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990), the Government of Karnataka hereby makes the following rules, namely :-

RULES

1. Title and commencement:- (1) These rules may be called the Karnataka Backward Classes and Minorities Department Services (Cadre and Recruitment) (Amendment) Rules 2002.

(2) They shall come into force from the date of their publication in the official Gazette.

2. Amendment to the Schedule:- In the schedule to the Karnataka Backward Classes and Minorities Department Services (Cadre and Recruitment) Rules, 1997,-

(1) in the entries relating to the category of post of "Joint Director, Backward Classes and minorities Department (Rs.3825-5825)" at serial number 2, after the entries in column 6, the following proviso shall be inserted, namely:-

"Provided that, if the officers who have put in not less than five years of service are not available, officers who have put in not less than three years of service may be considered."

(2) The entries relating to the category of post of "Principal Residential Schools" at Sl.No.5 shall be deleted.

(3) in the entries relating to the category of post of "Office Superintendent/Inspecting Assistants" at serial number 9 in column (6), after the words "Seniority interse in a cadre being maintained" the following note shall be inserted, namely:-

"Note:- If eligible persons in any cadre referred to above are not available to fill up the posts earmarked to that cadre, those posts shall also be filled from persons belonging to any other cadre specified above".

(4) the entries relating to the Category of post of 'Graduate Teachers' at serial number 10 shall be omitted.

(5) the entries relating to the category of post of 'Graduate Hindi Teachers' at serial number 11 shall be omitted.

(6) the entries relating to the category of post of "Backward Classes Inspectors" at serial number 14, in column (5), the following note shall be inserted, at the end, namely:-

"Note:- The post shall cease to exist on promotion of all the incumbents."

(7) in the entries relating to the category of post of "Wardens of Post Metric Hostel (Men)" at serial number of 17.-

(i) for the entries in column (5), the following entries shall be substituted, namely:-

"Seventy percent by promotion from the cadre of Superintendent Pre-metric Boys Hostel (Men) and thirty percent by promotion of Ashram School Teachers (Men) Trained or Untrained."

Provided that un-trained Teachers shall be considered for promotion after exhausting trained Teachers.

Note:- If eligible persons from the cadre of superintendent, pre-metric Boys Hostel (Men) are not available, the posts meant for that cadre shall also be filled from the cadre of Ashram School Teachers (Men) trained or untrained and vice versa."

(ii) for the entries in column (6), the following shall be substituted, namely:-

"For promotion:-

Must have put in a service of not less than five years in the cadre specified in column (5):

Provided that if persons who have put in not less than five years of service are not available; persons who have put in not less than three years of service may be considered"

(8) in the entries relating to the category of post of "wardens of post metric Hostels (Women)", at serial number 18.-

(i) for the entries in column (5), the following shall be substituted, namely:-

By promotion from the cadre of Superintendents Pre-metric Girls Hostel (Women), Ashram School Teachers (Women) and Women Welfare Centres Organisers in the following ratio:-

(1) Superintendents Pre-metric Girls Hostel (Women)	50%
(2) Ashram School Teachers (Women)	25%
(3) Women Welfare Centres Organisers	25%

Note: Untrained, Ashram Schools Teachers shall be considered for promotion only after exhausting Trained Teachers. If eligible persons in any feeder Cadre specified above, are not available to fill up the post earmarked to that cadre those posts shall also be filled from persons belonging to other cadres referred to above".

(ii) for the entries in column (6), the following shall be substituted, namely:-

"For promotion: Must have put in a service of not less than five years in the cadre specified in column 5.

Provided that if the persons with not less than five years of service are not available, persons with not less than three years of service may be considered for promotion."

(9) in the entries relating to the category of post of "CPED Teachers" at serial number 19 shall be omitted.

(10) the entries relating to the category of post of "Teachers" at serial number 20 shall be omitted.

(11) in the entries relating to the category of post of "Tailoring" at Training Instructors (Trained) at serial number 24, for the entries in column (6), the following shall be substituted, namely:-

"For Direct Recruitment"- Must have passed SSLC or equivalent examination with Diploma in Tailoring of an institution recognised by the Department of Technical Education or P.U. Vocational Course with tailoring as a subject."

(12) in the entries relating to the category of post of "Second Division Assistants" at serial number 26, in column (6) under the heading for promotion in item (ii) for the word 'seven' the word 'five shall be substituted.

(13) in the entries relating to the category of post of "Superintendents of Pre-metric Boys Hostels", at serial number 27 for the entries in column (6), the following shall be substituted, namely:-

"For Direct Recruitment:-

Must be holder of a degree or equivalent Examination with degree of Bachelor of Education".

For Promotion:-

(i) Must have passed SSLC or equivalent examination

(ii) Must have put in a service of not less than seven years in the cadre of cook of which not less than three years after passing SSLC,

(iii) Must have knowledge in reading and writing of Kannada".

(14) in the entries relating to the category of post of "Superintendent of Pre-metric Girls Hostels", at serial number 28, for the entries in column (6); the following shall be substituted, namely:-

"For Direct Recruitment:-

Must be holder of a Degree or Equivalent Examinations with degree of Bachelor of Education.

For Promotion:-

(i) Must have passed SSLC or equivalent examination

(ii) Must have put in a service of not less than seven years in the cadre of cook and Conductress of which not less than three years after passing SSLC.

(iii) Must have knowledge of reading and writing Kannada."

WHEREAS the draft of the Karnataka Backward Classes Department Services (Cadre and Recruitment) (Amendment) Rules 2007 was published in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act 1978 (Karnataka Act 14 of 1990) as required by clause (a) of sub-section (2) of section (3) of the said Act, in Notification No.SWD 239 BET 2007, dated 31.08.2007, in part IV-A of the Karnataka Gazette (extraordinary) dated 31.08.2007 inviting objections and suggestions from all the persons likely to be affected thereby within fifteen days from the date of publication of the Notification in the Official Gazette;

WHEREAS the said Gazette was made available to public on 31.08.2007;

AND WHEREAS the objections and suggestions received in respect of the said draft have been considered by the Government.

NOW, THEREFORE, in exercise of the powers conferred by sub section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act 14 of 1990) the Government of Karnataka hereby makes the following rules, namely:-

RULES

1. **Title and Commencement:-** (1) These rules may be called the Karnataka Backward Classes Welfare Department services (Cadre and Recruitment) (Amendments) Rule, 2007.

(2) They shall come into force from the date of their publication in the official gazette.

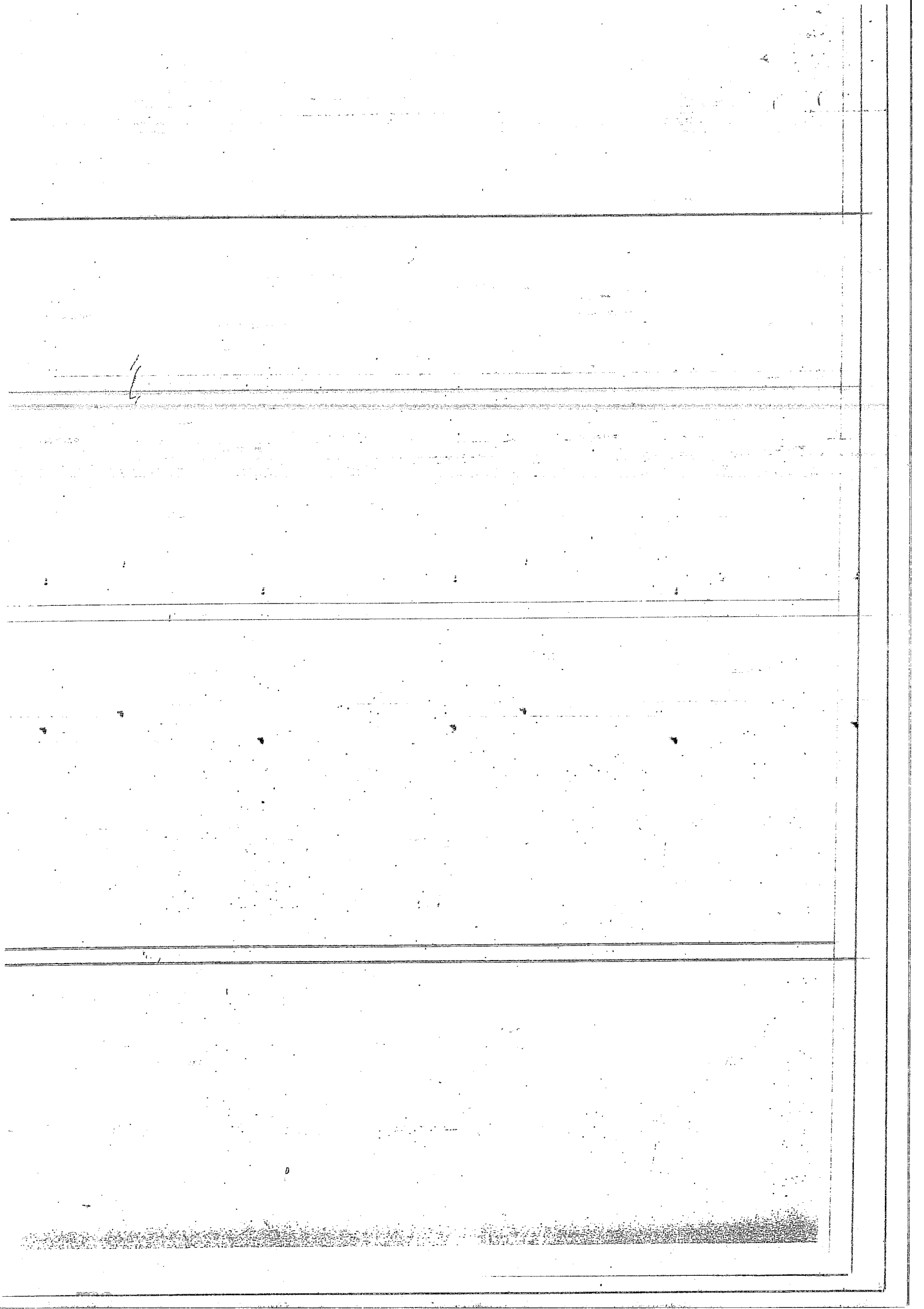

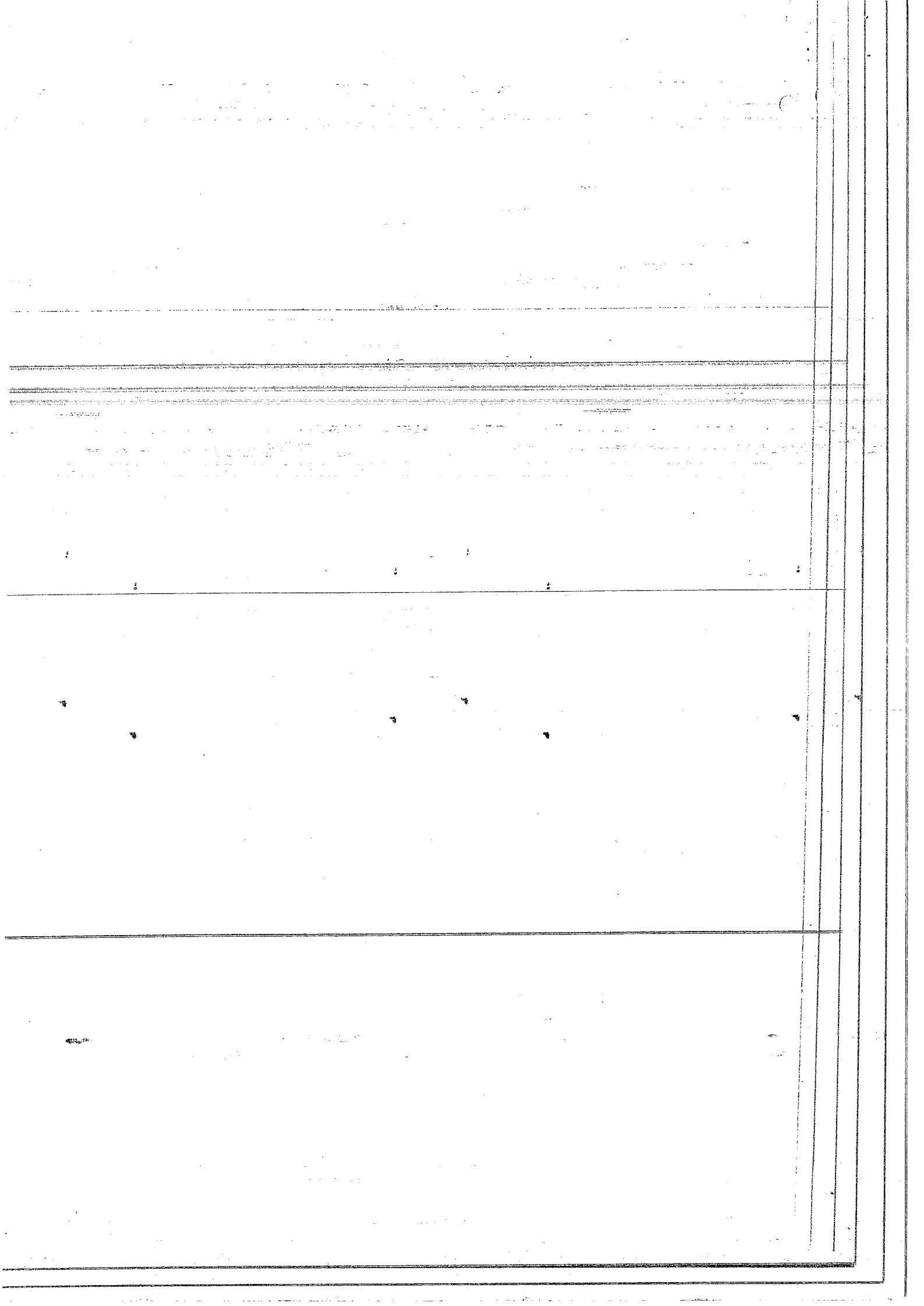

Whereas the Government of Karnataka is of the opinion that refusal to work in the service or employment or class thereof specified in column (2) of the table below would prejudicially affect the maintenance of public utility services, the public safety, maintenance of supplies and service necessary for the life of the community and would also result in the infliction of great hardship on the community.

Now, therefore, in exercise of the powers conferred by sub-clause (iii) of clause (a) Sub-Section(1) section 2 of the Karnataka Essential Services Maintenance Act, 1994(Karnataka Act.21 of 1994) and in supersession of all previous notification issued in this behalf, the Government of Karnataka hereby declare the service, employment or class thereof specified in column (2) of the table below to be essential services for the purpose of the said Act.
